Whereas, the District therefore has agreed to the rules and regulations promulgated by OHSAA:

It is therefore resolved as follows:

- 1. The operation of unmanned aerial vehicles (UAVs), commonly known as drones, is prohibited on Parkway Local School District premises during District-sponsored contests (including scrimmages and previews), practices and activities under the auspices of the Ohio High School Athletic Association (OHSAA).
- 2. District officials may deny admission or entry to anyone attempting to use a UAV until the event has been completed.
- 3. Any exceptions to this regulation must be approved in advance by the Superintendent.
- f. Approve Ryan Twigg as the Mentor Teacher for Leslie Baltzell for the 2015-16 school year.
